1. **Call meeting to order, announce quorum, and welcome** – Mayor Pro Tem Wilkerson called the meeting to order at 6 pm on August 8th and declared a quorum. Alderman present include Joe Wilkerson, Chris Heisler, Chris Strawn and Sandy Scoggins. Mayor Bewley was absent at the start of the meeting
