The Board may only: (1) make a statement of fact regarding the item; (2) make a statement concerning the policy regarding the item; or (3) propose the item be placed on a future agenda.


6. Discuss and take appropriate action on the potential abandonment of the City-owned alley situated near 402 Church street as initially requested by Chase Cashion.
